Approval of November 2024 meeting minutes: Allison Fagan made a motion to approve, and Reshma seconded. Motion passed unanimously.

Co-Presidents Report – Allison Fagan

- Boosters Boast What we do for ALL student-athletes.
- Grants
  - Boys Ice Hockey/ ice cost: requesting \$2,000 The board received their receipt showing they pay \$24,000 total for ice time. The board recommends funding the \$2,000 request in full. Allison Fagan made a motion to approve, and Catherine Liguori seconded. Motion passed unanimously.
  - o Girls Ice Hockey/ ice cost: requesting \$6710 The board recommends partially funding at \$2,000. Allison Fagan made a motion to approve, and Reshma Shah seconded. Motion passed unanimously.
  - Golf Team/ 2 Tournament entrance fees: requesting \$1,150 The board recommends funding this grant in full. Reshma Shah made a motion to approve, and Kim McGovern seconded. Motion passed unanimously.
  - Sailing Team/new racing sails: requesting \$3812—Because the sailing team is still not fully funded by the district, the board recommends partially funding this grant at \$2,000 due to our current budgetary restraints. Reshma Shah made a motion to approve, and Julie Broderick seconded. Motion passed unanimously.
  - Baseball/Game Changer premium pass: requesting \$898 The board discussed how providing online access for coaching staff and parents doesn't fall within our mission to support student athletes. Baseball is welcome to submit a grant that directly supports the athletes. The board is not recommending funding this grant.

- LCJSMS board position –Welcome Jen Jones as our new LCJSMS & Community Liaison - thank you so much for volunteering! Catherine Liguori made a motion to approve, and Kim McGovern seconded. Motion passed unanimously.
- Senior Athletic Celebration: May 14, 2025, Morgan Molhmann, Assistant to the AD, will head the slideshow. Thank you! We continue to need parent volunteers and involvement.
